
The following statistics, and the summary Statement of Condition, highlight the financial performance of the Credit Union for 2007. Total assets as of the end of 2007 were \$61,925,370. Net loans have grown to a level of \$52,190,269 resulting in a positive Loan to Asset Ratio of 84%. Total Member Capital, a critical measurement of financial stability, is at a level of \$7,242,156, resulting in a Capital to Asset Ratio of 11.7%. This ratio of Capital to Assets places the Credit Union among the top financial institutions in this key performance measurement.
